SCHOLARSHIPS

CONCERNS OF POLICE SURVIVORS (C.O.P.S.)

C.O.P.S. scholarships provide financial assistance to surviving children** and to surviving spouses** of law enforcement officers killed in the line of duty, according to C.O.P.S. scholarship criteria, who wish to pursue a course of study beyond high school. Types of higher education include students enrolled in undergraduate and post-graduate studies at an accredited college or university, or enrolled at an accredited trade/vocational school.

** Surviving children and spouses shall be eligible provided the survivor is not entitled to a tuition-free education as a state death benefit. If an eligible survivor applies for a state benefit and is denied, the survivor will then become eligible for a C.O.P.S. scholarship. **

HOW MUCH IS THE SCHOLARSHIP?

C.O.P.S. Scholarship recipients are eligible to receive up to \$2,000.00 per semester, with a lifetime maximum amount not to exceed \$16,000.00

WHEN SHOULD STUDENTS APPLY?

Applicants should apply for assistance using the process listed below for EACH semester they are wishing to be considered.

No applications will be accepted after the deadline listed below for each semester.

- Summer Semester: April 1st
- Fall Semester: June 1st
- Winter/Spring Semester: October 1st

WHAT DOES C.O.P.S. NEED FROM YOU?

To be considered for the C.O.P.S. Scholarship, students will need to complete the following:

- Fill out and sign the C.O.P.S. Scholarship application.
- Provide ALL required documentation listed on pages 2 & 3 of the application.
- Submit your completed application & required documentation to the National Office.

WHEN WILL YOU HEAR FROM C.O.P.S.?

The scholarship committee will meet 1-2 weeks after the scholarship deadline to go over the applications received. It

is always the goal to notify students of the decision of their application and have funds sent to their respective schools within 30 days after the application deadline.

If the committee has any questions, they will reach out to you. Please make sure to provide C.O.P.S. with the correct phone number and email and be sure to monitor that regularly so they are able to move forward with applications submitted.

FIRST RESPONDERS CHILDREN FOUNDATION

Thank you for your interest in the GI College Success Academy Program. The application process is quick and easy and usually takes less than 10 minutes.

BRADY'S K9 FUND

THE NEED IS REAL. THE TIME IS NOW.

Police K9s take on tasks humans can't, like detecting explosives, narcotics, and weapons, tracking fugitives, and locating missing persons. These duties often put them in dangerous situations, and they face greater risks than their human partners. Yet, unlike officers, K9s aren't issued ballistic vests.

Most agencies can't afford protective gear for their K9s, and many are prohibited from buying equipment not for human use.

That's why we need your help.

In 2018, 8-year-old Brady Snakovsky started a nonprofit to provide ballistic vests to K9s. So far, hundreds have been outfitted, but Brady needs your support to keep these K9s safe.

FREE BULLET PROOF VESTS PROGRAM FOR LAW ENFORCEMENT OFFICERS

Thousands of law enforcement professionals in the United States are working in dangerous environments and they do not have a ballistic vest to protect them. Many officers are provided new ballistic vests by their employment agency every five years. Most manufacturers of ballistic armor have set 5 years as the limit to how long they will warranty their product. While the manufacturer warranty may be expired, often the vest will still effectively protect those that do not have one. Over the last several years

St. Michael's Shield has tested numerous expired vests and has found them to still possess the ability to stop projectiles.

The Armor of God Project began in 2009 and in 2018 transitioned into Vest For Life and is now located in Knoxville, TN. Their mission is still dedicated to protecting those that protect us by providing donated ballistic vests to officers that need them.

We encourage you to assist them in any way that you are able in order that they may be able to provide every law enforcement officer with this basic safety equipment free of any costs except for shipping. Through the efforts of a small cadre of volunteers, financial supporters, and those praying daily, thousands of ballistic vests have been given out and lives have been saved.

STANTON FOUNDATION

FALLEN K9 REPLACEMENT GRANTS

To honor the lives of K9s lost in the line of duty, the Stanton Foundation offers grants of up to \$15,000 to fund the purchase of a new K9 and a bulletproof vest. The Foundation makes a binding commitment to provide the funds when an application is accepted. The funds become available to the Department within two weeks of receiving an invoice for the purchase of the K9 and the vest. To be eligible, the department must:

- Have lost an active, on-duty K9 during a deployment (including transportation), a training event, or patrol activities within the past 12 months;
- Be financially prepared to send the new K9 to appropriate training;
- Submit the invoices for purchases within six months of having their application accepted.

The fallen K9 must not:

- Have died due to a genetic or medical condition unrelated to his service;
- Have died due to handler or departmental error*;
- Have died outside of a deployment (including transportation), a training event, or patrol activities;
- Have died more than 12 months ago.

This program is not competitive and is directed toward any police department in the United States. The Stanton Foundation will award grants to any eligible department that successfully completes the application process. To apply, a department should complete an application and await Foundation approval. Upon approval of the application, the department must sign a certification statement. Thereafter, the department may purchase a K9 and bulletproof vest and provide invoices to the Foundation for prompt reimbursement. To review the application, please visit our Resources page.

COUNSELING

CONCERNS OF POLICE SURVIVORS (C.O.P.S.) COUNSELING PROGRAM

ELIGIBILITY

Any dependent child of a law enforcement officer killed in the line of duty (according to federal government criteria) since May 14, 1984, is eligible.

All information submitted to Concerns of Police Survivors in conjunction with the “C.O.P.S. Kids” program will be treated as confidential, privileged information. Family surnames and names of children will never be included in any printed report that leaves the National Office.

FILING A CLAIM

Complete the “C.O.P.S. Kids” Counseling application form (located at www.concernsofpolicesurvivors.org/counseling), along with a copy of the child’s birth certificate, and submit to the C.O.P.S. National office. Be sure to include the counselor information on the application if known. A C.O.P.S. staff member will follow-up with you after the application has been reviewed with further instructions.

FUNDING LIMITATIONS

The “C.O.P.S. Kids” Counseling program will assist with the out-of-pocket costs that are incurred for counseling up to \$6,000 per eligible child. Payments can be paid directly to the mental health professional or reimbursed to the responsible parent/guardian. If counseling for the parent/guardian is recommended by a health care professional in conjunction with the child’s counseling, C.O.P.S. will assist with out-of-pocket costs up to \$4,000. Eligibility for this program ceases on the surviving child’s 22nd birthday. Please refer to their Standard Operating Procedure at the website provided below to review the complete “C.O.P.S. Kids” Counseling criteria.

REAPPLYING FOR ADDITIONAL ASSISTANCE

If after reaching the funding limitation of \$6,000, and additional psychological counseling is still suggested, you may reapply by writing a letter to the C.O.P.S. National Office stating the need for additional financial assistance. The C.O.P.S. National Board will review and consider each request on a case-by-case basis.

MEMBERSHIP ELIGIBILITY

All levels of membership to Law Enforcement United, Inc. are limited to:

- Active or retired Law Enforcement Officer or Corrections Officer who is either sworn or is eligible for Public Safety Office's Benefits (P.S.O.B.) by the U.S. Department of Justice
- Immediate family member of a Law Enforcement Officer (L.E.O.) or Corrections Officer that died in the line of duty ("Survivor") who is eligible for Public Safety Office's Benefits (P.S.O.B.) by the U.S. Department of Justice
- Civilian (non-sworn/non-survivor) that is sponsored by an active member of Law Enforcement United, Inc. who is an Active or Retired Sworn Law Enforcement Officer or Corrections Officer, or a Law Enforcement United Survivor.
- All members & participants must be 18 years of age

Credentials must be available to the Executive Board or Designee upon request for verification purposes. Credential requirements may include active department photo ID, or verification of survivor relationship from COPS, Civilian requirements would be written (electronic or hard copy) letter from Sponsor to the National Board.

PROGRAMS CONTINUED

Members are required to adhere to Law Enforcement United Standards of Conduct, keep membership up to date, and meet all financial obligations to remain in good standing.

Members who register to participate in any LEU bicycle ride event do have to meet minimum fundraising requirements to attend, ensure their participation registration is up to date, submit all forms, and meet all deadlines. For more information see our Fundraising Page

MEMBERSHIP DUES

Membership pays annual dues of \$75.00

MEMBERSHIP RENEWALS

July 1st is when annual membership renewals begin. Dues are \$75.00 and are due at the time of renewal.

A 30-day grace period is extended to membership renewals. Financial hardships should be communicated to the National Board prior to July 15th for consideration of an extension or other arrangements. July 31st any member that has not renewed their membership dues will be removed from the membership database and no longer active or eligible to participate in any LEU sanctioned events.

Smart homes host a myriad of features such as automated doors and lighting, wider halls and doorways, special showers to accommodate wheelchairs, automatic door openers, cabinets, counters, and stove tops that can be raised and lowered, backup generators, and central heating and air conditioning systems that can be controlled by tablets. These homes help our most severely injured veterans and first responders to reclaim their day-to-day independence.

Our process is a simple one. Simply fill out the application and one of our liaison officers will contact you and walk you through the screening process and help you complete it together. It is simple, confidential, and comes without any obligation.
